### Agreement

3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dogs Distemper/Hepatitis/Parvo Virus vaccinations are current.
4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including but not limited to, the condition of any fields/arenas, grassed areas, dirt areas, floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fitting, show rings. Parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.
5. Exhibitor/owner releases ADAC Agility (including ADAC Agility officers, members and employees), and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, however, such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons
